
Section 2, Accounting statements, Accounting for Fixed Assets

It has come to our attention that Box 9 of Section 2 of the Annual Return, the Accounting Statements, includes fixed assets that have not been given a value. The Practitioners Guide strongly recommends that assets that are 'community assets' that have no functional purpose or any intrinsic resale value (for example, a village pond or a village green) are disclosed in Section 2, Box 9 of the Annual Return at £1 as a proxy for the zero cost.

Guidance on accounting for fixed assets is available in the NALC / SLCC publication Governance and Accountability for Local Councils – A Practitioners Guide (England) (paras 3.76-3.77).

The Council should restate the 2016 figures on next year's Annual Return and write 'Restated' beneath the £ sign on the 2016 column.

The Practitioners' Guide has been updated in 2016 and new guidance on accounting for fixed assets will apply in 2016/17. The Council should review this guidance when completing the 2016/17 Annual Return and ensure that it classifies its assets appropriately and the correct value of the asset is included in Box 9.
